- 5. COPY OF YOUR DRIVERS LICENSE or STATE ISSUED I.D.
- 6. MUST ALSO SUBMIT ORIGINAL
  - US Visa (F1, H1B, etc.) I-20 I-94
  - ORIGINAL Permanent Resident Card
- 7. PROOF OF PAYMENT -
  - Pay by Credit or Debit card through Arista website under "VISA FEE" tab
  - Print copy of receipt to submit with application
- 8. Supporting documents Provided by USC (Flight Itinerary & USC Letter of Support)

#### **ADDITIONAL REQUIREMENTS** – if applicable

For travelers who were born in China, Hong Kong, Macau or Taiwan and became citizens of other nationality.

- Former Chinese citizens who obtained another citizenship MUST present one of the following:
  - Your most recent previous Chinese passport
  - Your most recent previous Chinese travel document used to enter in the USA <u>OR</u>
  - Your most recent Chinese visa issued to them
- Your original Chinese name MUST BE WRITTEN in Chinese characters in the appropriate field on the visa application form
- Proof of name change: If the applicant's name has changed since birth, please provide the original court order, naturalization certificate, or marriage certificate showing the official name change
